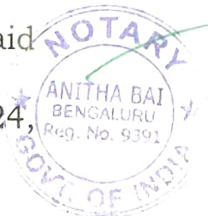

 91 is verified by concerned Engineer and Secretary Sri B.N.Ravi on 29.6.2024. It is observed that the said building is having four floors including the basement with light roofing on the terrace. You informed during inspection that the said building was constructed in the year 2016. Said building is having 23 rooms with toilets having vetrified and granite flooring, Alluminium and U.P.V.C. windows wooden doors.

Further as there are no reports regarding use of concrete grade, Steel, Cement, sand for construction of the building, two non distinctive tests are conducted as mentioned in Government circular at Ref (2).

Accordingly, Dr N.Jayaramappa B.E.(Civil) ME (Str) Ph.d Professor of Bangalore University, Department of Civil Engineering (U.V.C.E) has conducted Form for Certificate for structural Design sufficiency Report (Annex C Clause 12.2.8) Ultrasonic pulse velocity Test Report and in the said report is it mentioned that the building is

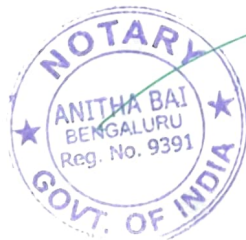
