In your letter in ref (2), stating that the installation of the fire extinguishment equipment in the said building has been completed and requested to issue completion certificate from the Fire and Emergency Services Department.

As per your request, the officers of the Fire and Emergency Services, on 08.08.2024 inspected the building constructed on No.23/24. Sai Baba Nagara, Andhrahalli, Vishwaneedam Post, Yeshwanthapura Hobli, Bangalore City and informed that as per the advisory letter issued by the Fire and Emergency Services Department, completely implemented the installation of fire protection equipments and fire extinguishment equipments and taken all the precautionary measures in the building and only providing training to the employees/staffs of the building regarding the fire protection is pending and after issuance of the completion certificate, it is possible to provide training for the staff.

Therefore, as mentioned in the advisory letter of the Fire and Emergency Services Department vide No.GBC(2)1457/2024, dated: 01.08.2024 for the educational building of Vidya Bhooshan International School consisting of Ground and 5 upper floors of 24.40 meters height constructed on No.23/24, Sai Baba Nagara, Vishwaneedam Post, Yeshwanthapura Hobli. Andrahalli. the safety measures not followed properly or if any additional constructions made in the open space around the building left as per rules or any disturbances caused permananently/temporarily, this completion certificate will stands cancelled and the further action will be initiated in accordance with law.
